

# SUPPLIER CODE OF CONDUCT

# INTRODUCTION

At iWOW TECHNOLOGY LIMITED ("iWOW"), we embrace the core principles of the UN Global Compact and are committed to fostering ethical business relationships with our suppliers. We expect our suppliers to adhere to the highest standards of ethics, integrity, and corporate social responsibility. This Supplier Code of Conduct serves as a guideline for our suppliers to align with our values and commitments.

# 1. COMPLIANCE WITH LAWS AND REGULATIONS

1.1 Adherence to Legal Requirements: Suppliers must adhere to all applicable laws and regulations in the countries where operations are conducted, including but not limited to, regulations regarding corruption, bribery, insider-trading and ethical business practices.

1.4 Insider-Trading: As iWOW is listed on the Singapore Stock Exchange, suppliers shall ensure that any unpublished Price Sensitive Information obtained in the course of fulfilling its contractual obligations are restricted to direct team members and on a need to know to basis only. Any use of such information for financial gain will constitute an offence of insider trading.

# 2. LABOR AND EMPLOYMENT PRACTICES

2.1 Prohibition of Child Labor: Suppliers are prohibited from employing individuals below the minimum legal working age as per international labor standards and local laws.

2.2 Forced Labor: Suppliers must not utilize forced, bonded, or involuntary labor in any form, and employees should be free to leave employment after reasonable notice.

2.3 Fair Compensation: Suppliers are expected to provide fair wages, benefits, and safe working conditions for their employees, in compliance with all applicable wage laws and regulations.

# 3. ENVIRONMENTAL RESPONSIBILITY

3.1 Compliance with Environmental Laws: Suppliers are required to comply with all pertinent environmental regulations and should strive to minimize their environmental impact through responsible operational practices.

6.1 Suppliers who become aware of any violations of this code of conduct are obligated to report them to iWOW TECHNOLOGY LIMITED's designated contact person promptly.
